Residential	4.5 mils (minimum \$400.00)
Commercial	14.75 mils (minimum \$400.00)
Vacant Land	4.5 mils (minimum \$200.00 per parcel)
BUSINESS TAX	
<b>General Commercial:</b> all other businesses with no specific designation.	12.5
<b>General Industrial:</b> motor vehicle repairs, welding and fabrication shops, marine base operations, boat building, heavy civil, roads, w/s, trucking.	20.5 mils
<b>General Contractor:</b> roofing, plumbing, electrical, HVAC, siding installation, residential & commercial construction.	15.5 mils
<b>Professionals:</b> medical, dental, therapeutic, pharmaceutical, legal, financial, engineering, IT, consulting.	20.5 mils
<b>Food, Beverage &amp; Confectionary:</b> convenience stores, grocery stores, lounges, pubs, bars, restaurants, coffee shops, ice cream shops, bakeries.	13 mils
<b>General Retail:</b> clothing stores, sporting goods, craft shops, gift shops.	5 mils
<b>Tourist Accommodations</b>	5 mils (minimum \$350.00)
<b>Tour Operators</b>	12 mils (minimum \$2,500.00)
<b>Minimum Business Tax</b>	\$450.00/annually
<b>Minimum Home Business:</b> all other home businesses that do not fall into the medium or light industry categories.	\$450.00/annually
<b>Home Business (Medium Industry):</b> studios, salons/spas, pet grooming, photography, private daycares.	\$300.00/annually
<b>Home Business (Light Industry):</b> fabrication of handmade articles such as clothing, arts & crafts, workshops.	\$150.00/annually
<b>Roadside &amp; Mobile Vendors</b>	\$250.00/annually
<b>Direct Sellers</b>	\$250.00/annually
<b>Utilities</b>	2.5 % of Gross Revenue
<b>No Fixed Place of Business</b>	5.0 % of Gross Revenue

Development Regulation & Town Plan Amendment Fee	\$5,000.00

An 8% discount will be applied to residential property taxes paid in full by June 30, 2022. All taxes are due and payable by June 30, 2022.
